RESOLUTION NO. 23-1081

A RESOLUTION DESCRIBING THE CORPORATE LIMITS AND BOUNDARIES OF THE CITY OF OLATHE, KANSAS.

WHEREAS, K.S.A. 12-517 requires that a city declare by resolution the entire boundary of the city prior to the last day of December in any year a city changes its boundary; and

WHEREAS, the Governing Body has approved two (2) annexations totaling 226.57 acres (0.35 square miles).

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF OLATHE, KANSAS:
